#### **MESSAGE FROM NANCY**

One of the current priorities of the Hearing Loss Association of America (HLAA) is to "loop

America." What is the reason for this effort?

Inductive loops are one of the three types of assistive listening systems (the others are infrared and FM), but what makes the loop special is that people with telecoil-equipped hearing aids or cochlear implants do not need to use a receiver. Loops transmit sound via an electromagnetic signal, which is picked up by the telecoil. Not long ago, only about 30% of hearing aids had telecoils, but

that number has now doubled, and all cochlear implants have them. Not needing to use a receiver means not needing to check one out and return it, not needing to worry about whether the receiver battery is dead, no possibility that not enough receivers will be available, and no need to use a visible device. All the user has to do is activate the telecoil. (Receivers can be provided to those who lack telecoils.)

Many HLAA chapters have long used portable loops for their meetings. The new push is to get loops permanently installed in such locations as houses of worship, retirement community meeting rooms, and ticket counters, and to make more hard of hearing people aware of the benefits of telecoils.

#### Fall State Happenings

The HLA-PA Advisory Council elected 4 new members at its

**August 22** Wyndham Garden Valley Forge Hotel, Exton, PA. HLA-PA co-hosts Reception for Congressman, Jim Gerlach of Pennsylvania's Sixth District.

Representative Gerlach is an original co-sponsor of the Hearing Aid Tax Credit Bill (HR 1479), which provides a \$500.00 tax credit every 5 years to people with incomes of less than \$200,000 a year. The credit applies to those who need hearing aids and are either over 55 or purchasing a hearing aid for a dependent. The reception dinner was complimentary to those who attended. All HLA-PA members and interested friends or family members were invited. Pictures and more details will appear in the winter issue of HearSay. Many may remember that HLA-PA organized a well-attended reception in 2009 for Congresswoman Allyson Schwartz, in honor of her sponsorship of the Hearing Aid Tax Credit Bill.

Carolyn Meyer, with the assistance of Diana Bender, applied for a grant to fund the "Looping Initiative" in the state to benefit all those with hearing loss who have telecoils in their hearing aids or cochlear implant processors. HLAA has been promoting this and now HLA-PA will be able to pursue this effort in Pennsylvania. Details about this project will be included in the winter issue of HearSay.

#### **Spirit of HLAA Award**

We are pleased to announce Kay Tyberg, founder and president of the HLAA of Lycoming County chapter, as winning the Spirit of HLAA Award at this year's national convention!

Kay has been very active for many years in advocating for people with hearing loss at various state-level meetings and conferences in Pennsylvania. She has been accepted to serve on the Pennsylvania Advisory Council for the Deaf and Hard of Hearing (awaiting official appointment by the Governor) and on the HLA-PA Advisory Council, and serves on the Commonwealth of PA Hearing Aid Sales Registration Law Advisory Council. In addition to numerous other responsibilities, Kay is a student at two different colleges, including Penn State University, where she has been advocating for accessibility for hard of hearing students.

Kay leads the HLA-Lycoming County chapter, which has been proactive in advertising, utilizing their local newspaper radio station and the Internet. They are meeting with nursing homes, senior citizen centers, (Continued on page 3)

health facilities, and veterans' care organizations to tell them about HLAA. Kay and her vice president appeared on a local radio talk show and were so well received that one listener drove to the radio station to meet them! They have appeared on local TV and have written articles for several newspapers about hearing loss and their chapter. When one editor thought their meetings were not newsworthy, Kay pursued the issue with supervisors, who then agreed to publish an article about the chapter. In addition, she has organized various fundraisers, including a candy-making project that involved all members. In addition to her leadership of the Lycoming County chapter, Kay also serves as the vice president of the Central PA chapter.

Kay also serves as a resource for questions about hearing loss. She is active in her church and extended family, and finds time to teach a course in ASL in her community. Kay is dealing with health issues and coping with hearing loss while at the same time providing leadership in so many different ways, we simply don't know how she does it all!

#### The Reverend Paul Harris

The Reverend Paul Harris, a United Methodist Pastor, died on July 24, 2012 at the age of 96, at Cornwall Manor where he and his wife Jane lived after their retirement. Paul was an active member of the Hearing Loss Association (formerly SHHH) almost since its inception. He started a chapter of Self Help for Hard of Hearing People at the Methodist Church in Media, PA in 1982, 3 years after the founding of our national organization. This chapter, The Delaware County Group for the Hard of Hearing (DELHOH) grew by word of mouth and announcements in local newspapers. This chapter still exists.

Paul had a deep understanding of human nature and understood the importance of allowing people to talk about the pain and often humor that accompanied their need to cope with their hearing loss. He understood the need to educate people about strategies to deal effectively with their hearing loss. He was the first person I ever knew to have parts of his home "looped" so he could better hear what people were saying.

Paul recognized that many people with hearing loss did not know where to turn for help. When he moved to Cornwall Manor he started the Lebanon Chapter for the Hard of Hearing (LEBHOH). Paul led this group and edited their newsletter for as long as he could. Interestingly, this area of PA has the largest HLAA membership in the Commonwealth of PA. I attribute this to Paul!

This kind and gentle man has created a living legacy for people who are hard of hearing. He leaves many people who can cope with hearing loss because of his initiative.

Thank you, Paul.
