## MESSAGE FROM NANCY

One of our responsibilities as people with hearing loss is to educate others about how to communicate more effectively with us. We can ask people to face us, speak a little slower, rephrase what we don't understand, and the like. It's also important to realize that communication habits can be difficult to change. Since people focus on what they are saying rather than on how they are saying it, a failure to consistently do what we ask doesn't necessarily imply insensitivity on their part.

Some people are especially attuned to hard of hearing communication needs, and we are

fortunate if any of them are in our social circle. They notice if a speaker is covering his or her mouth or facing away from us, and they let those people know. They also fill us in on what we miss without having to be asked. But most people aren't that observant, so we need to be prepared to give gentle reminders when necessary.

There are also a number of simple ways to improve the communication setting. For example, we can ask the host or hostess to reduce background noise by turning off the television, and we can take the seat by the window at a restaurant so the faces of others at our table won't be in a shadow.

**February 2:** HLA-PA ASSISTIVE LISTENING DEVICE (ALD) DEMO KIT COMMITTEE MEETING Attending were members Alan Kutner, Don Groff, Nancy Kingsley, Carolyn Meyer (absent: Diana Bender, Donna Schumacher). The committee voted to appoint Bill Best of the Chesco chapter as the “HLA-PA Assistive Listening Device Coordinator.” Bill completed HLAA’s Hearing Assistive Technology (HAT) Training Program in October 2012 at the University of Colorado. The HAT program is supported by a grant through the National Institute on Deafness and Rehabilitation Research (NIDRR) and the Rehabilitation Engineering Research Center on Hearing Enhancement (RERC-HE) at Gallaudet University. Training sessions cover hearing aids, cochlear implants, assistive listening systems, alerting and signaling devices, and telephone technologies. Attendees receive instruction on how

to advocate for technology in the workplace and public places. The Chesco chapter helped to subsidize Bill’s expenses for this weekend workshop. Bill has offered to travel up to 3 hours to demonstrate the ALD Kit upon request. For further information contact [best@hla-pa.org](mailto:best@hla-pa.org) or check out our state website.

### Signs- They Are A Changin'

For the deaf and HOH community, taking a yoga class is often an exercise in frustration. The nonprofit Deaf Yoga Foundation ([deafyoga.org](http://deafyoga.org)) is working to change this. Yoga teacher Lila Lolling, through the foundation, is hoping to make yoga more accessible to the more than 36 million deaf and hard-of-hearing people who live in the United States. The organization has partnered with Sivananda Ashram Yoga Ranch in upstate New York to create the only teacher training course with sign language interpreters. Lolling hopes

that yoga studios and conferences around the country will open their doors to deaf and HOH students. By practicing simple techniques, yoga teachers can draw more deaf and hard-of-hearing people to their classes. Some simple techniques non-signing yoga teachers can implement into their classrooms to welcome HOH and deaf students are:

1. Make eye contact---this establishes a sense of safety, boosts confidence, and builds trust.
2. Use natural gestures---demonstrate different moves by miming each position.
3. Guide by touch---it is difficult for HOH or deaf students to relax if they don't know when to open or close their eyes. Rouse students from Savasana or seated meditation by lightly touching their ankle or knee.

The Lycoming County Chapter of the Hearing Loss Association members participated in the HLA-PA Farm Show in Harrisburg on opening day, January 5, 2013. It was interesting to see not only native Pennsylvanians at the show, but also individuals with hearing loss from Maryland, New Jersey, New York, and Virginia.

We were in contact with individuals knowingly admitting they have a hearing loss, but in each case none of them had seen a doctor or an audiologist. We also met numerous individuals with hearing loss who had concerns and questions about their hearing aids.

Those who visited the booth asked many questions regarding topics such as cochlear implants vs. hearing aids, tinnitus, hearing aid costs, etc. Many veterans from the wars in Vietnam, Kuwait, Afghanistan, and Iraq also stopped by to discuss how the V.A. can help them with their hearing loss.

Visitors to the booth were also interested in HLA-PA literature, chapters and HearSay. In fact, HearSay was one of the only newsletters made available by the Farm Show vendors. HLA-PA members who volunteered at the Farm Show booth enjoyed making information available to attendees who greatly benefitted from assistance in dealing with their hearing loss.

**Diana Bender HLA National Convention  
Scholarship**

The Hearing Loss Association of Pennsylvania (HLA-PA) has established the Diana Bender HLA National Convention Scholarship to assist Pennsylvania residents who are members of the Hearing Loss Association of America (HLAA) to attend the HLAA convention. (Note that membership in a chapter is not the same as membership in HLAA; the latter is required for scholarship eligibility.) One scholarship will be available for a deserving person who has never attended an HLA convention and is currently involved with hearing loss issues. The HLA-PA Advisory Council’s Scholarship Committee will select the qualifying applicant.

**When and where is the 2013 HLA convention?**

The convention will be June 27-30 (four days, three nights) at the Oregon Convention Center in Portland (the DoubleTree is the host hotel).

**Who is eligible as a scholarship candidate?** Any Pennsylvania resident with hearing loss, regardless

of age, is eligible. The applicant must be a current HLA member and have never attended an HLA convention. He or she must have demonstrated an interest in remaining actively involved with hearing loss issues and must indicate that a scholarship would enable his or her attendance at an HLA convention.

**Scholarship amount:** The recipient will be awarded \$500 (to be applied to transportation, lodging, and meals) plus the cost of registration for the full-activity convention package (includes banquet). Any amount exceeding \$500 will be his or her responsibility. The awardee must attend the convention or return the \$500.

**Submission date:** Application forms may be emailed or mailed (email preferred if possible). Deadline for receipt is April 8, 2013. For more information, contact Mitchell Bilker, HLA-PA Scholarship Chair, at scholarship@hla-pa.org or 821 Rosehill Drive, King of Prussia, PA 19406.
