Our Lunch & Learn topic for this year is legal rights of people with hearing loss



(details are elsewhere in this issue). Hard of hearing people are often unaware of their rights or reluctant to advocate for them. Often all it takes is a simple request. When you ask for an accommodation (such as CART or an assistive listening system), it's important to be polite. If the initial response is unfavorable, explain that the accommodation is legally required (houses of worship and private clubs are exempt).

If you are refused, the Office for the Deaf and Hard of Hearing and the Human Relations Commission are state agencies that can help with advocacy, and the nonprofit Disabilities Rights Network of Pennsylvania can provide information and file lawsuits in certain cases. Much effort was involved in getting disability rights laws passed, and such laws have made our society far more accessible. If you go, when ordering tickets, always mention that you have a hearing loss and request to be seated so that you can see the caption screen or ASL interpreters.

Kay Tyberg's Perspectives on Peer Mentoring

As a graduate of Gallaudet University's Class of 2013 Peer Mentoring Program, let me explain what is involved. A peer mentor is a deaf or hard of hearing individual who is trained to provide advocacy, education, guidance, information, and support to help other people with hearing loss adopt new coping methods. We explain how individuals can advocate for themselves and help them overcome communication barriers in family relationships, work environments, and the community. We know how to make client assessments and comprehend audiograms. We understand what the clients are going through with hearing loss, because we live with it every day.

Gallaudet's Peer Mentoring Program is a two-year certification program, with costs covered by a grant, in which students study hearing loss in our society, biopsychosocial aspects, audiology, assistive technology, and practical application of peer mentoring. The educational materials are provided by the assigned graduate student facilitator from the department of audiology. The group meets face-to-face at the orientation and at graduation. In between, students meet weekly on Gallaudet's online Blackboard chat for a couple of hours. We also do written assignments related to our readings. A phenomenal amount of reading is involved, but it was worth all the time and effort. There is much interaction between us and we bond well. Information about the program is at www.peers4access.org.

As someone who has had lifelong experience with hearing loss, I want to make sure that others with hearing loss do not have to go through struggles and discrimination due to lack of knowledge and failure to obtain appropriate communication. Every time I learn about something that no one shared with me until it was too late, I've thought, "Why wasn't I told about this before? Things could have been so different in my life!" There is a great deal more available to help with hearing loss today than in the past, but finding information is still a challenge. I want to tell others about the available options and watch people's faces light up when they see something work for them for the first time.

I have been fortunate to have experience wearing hearing aids, and, when I became profoundly deaf in 2008, a cochlear implant. In addition, I have had lip reading training and am knowledgeable in sign language. Therefore, I can relate to various individuals with hearing loss. However, peer mentors are trained not to base mentoring solely on their own experiences. We have to examine and listen carefully to each client's needs and take the appropriate action to assist him/her. Mentors need to be active listeners and not push their own views. Mentoring is not about sharing my hearing loss journey with someone but about listening to theirs. Mentoring is also about educating everyone. I learned the importance of having discussions about hearing loss in stores, at meetings, in schools, and in other public places.

I have helped several couples address their hearing loss issues. At first I was nervous, but the program provided excellent guidance in interacting with clients, and the satisfaction of knowing I helped someone is enormous.
