#### **MESSAGE FROM NANCY**

By Nancy Kingsley, State Director Katherine Bouton (author of the popular Shouting Won't Help and currently an HLAA trustee) recently



wrote an AARP blog column titled "Frustrated by Silence at a Funeral." She bemoaned her inability to understand a friend's memorial service because the church didn't have a hearing loop. (An FM or infrared assistive listening system would have worked, too.)

But all is not lost. If a house of worship lacks an assistive listening system or if you are unable to benefit from one, CART realtime captioning can provide the needed communication access.

Funeral homes are required by Title III of the Americans with Disabilities Act (ADA) to provide effective communication, including assistive listening systems, CART, and sign language interpreting. Pennsylvania's Office for Deaf and Hard of Hearing (717-783-4912) will advocate for you if you encounter resistance. Houses of worship are exempt from the ADA but may be willing to provide CART for a funeral if this is requested.

If you will be attending a funeral Mass in a Harrisburg Diocese church, you can obtain CART or interpreting at no charge by immediately contacting Ginny Duncan, director of the Office of Ministry for People with Disabilities, at 717-657-4804 or vduncan@harrisburgdiocese.org. This access is also available (with two weeks' notice) for wedding Masses, First Communion, or Confirmation. Hopefully, other houses of worship will make similar provisions for requested communication access at important lifecycle events. So be sure to ask!

#### **STATE NEWS**


On September 10, Hamilton Relay held a Captioned Telephone Relay Service town hall meeting in Camp Hill. Sherrie LeuVay, Pennsylvania Captioned Telephone Outreach Coordinator, organized the event, which included refreshments and feedback from attendees. The presenters covered services available to people with hearing and/or vision loss. Nancy Kingsley, HLAA-PA's state director, discussed bills to enable Medicare to cover hearing aids and provided information about hearing aid features and types. Other



listed presenters were Stacy Phillips from Temple University's Institute on Disabilities; Sharon Behun from the Office for the Deaf and Hard of Hearing; Natalie Barbush from the Office of Vocational Rehabilitation; and Londa Peterson from Vision Resources of Central Pennsylvania. Marsha Drenth, program manager of Deaf-Blind Living Well Services at the Center for Independent Living of Central Pennsylvania, provided additional information at the end.

#### OUTREACH

On November 19 Diana Bender and Carolyn Meyer presented a program, "Communicating with Clients with Hearing Loss" to VNACS Agency Home Health Aides (Direct Care Workers) in Abington, PA. VNACS (Visiting Nurse Association Community Services) is a non-profit serving the Community in many different ways. Their outreach is directed toward custodial home care with private and county clients. DCWs in the State of PA must obtain 12 hours of educational credit to maintain their HHA credentials. Our HLAA-PA presentation was filmed to produce a few DVDs for the agency library. This allows the agency to share the presentation with the larger DCW staff who might not have been able to attend the presentation November 19. HLAA-PA has a DVD if anyone wants to view it (contact Carolyn Meyer, meyer@hlaa-pa.org). Home care staff often make suggestions of products such as ALDs that might be helpful to clients. Relevant catalogs were distributed.

Our 81 teams and many alliances raised over \$123K. We are looking forward to the 2016 Walk on Sunday October 9, 2016, which we are working to make even better!



# When Hearing Aids Aren't Enough, **Cochlear Implants Can Help**

Whether it happens suddenly or gradually over time, hearing loss can affect physical and emotional health. Being unable to hear impacts one's ability to socialize with friends, communicate with co-workers, and can force people to become more reliant on family members to constantly interpret for them.

By age 65, one out of three people will have a hearing loss, according to the Hearing Loss Association of America. Signs of hearing loss include:

- Difficulty understanding speech on the telephone
- Trouble following a conversation with two or more people talking at the same time
- Difficulty hearing in a noisy background
- Having to strain to understand conversation
- The need to ask people to repeat themselves
- Misunderstanding others and responding inappropriately

If you or someone you know is experiencing more than two of these signs, it could be beneficial to schedule an evaluation with a certified audiologist to learn if your loved one has a hearing loss. For people diagnosed with severe to profound hearing loss, who no longer benefit from hearing aids, there may be a solution. Unlike a hearing aid that amplifies sound, a cochlear implant is an implantable solution designed to mimic natural hearing using sophisticated software and state-of-theart electronic components.

Ann Dexheimer, a former certified American Sign Language interpreter and teacher for the Deaf and Hard of Hearing Program in Sonoma County, was diagnosed with hearing loss as a child. Starting at age 12, her progressive loss started to worsen.

Throughout her career, Dexheimer had taken professional courses and learned about cochlear implants, a technology that is often covered by many private

health insurance plans and Medicare, and may be covered by Medicaid. Because her own hearing had worsened, it dawned on her in a class one day that she should consider getting a cochlear implant herself. "For me it was a nobrainer. I'd seen the remarkable success of children with cochlear implants."

Having a cochlear implant has become more than a device to assist her in hearing. "It becomes who you are," Dexheimer says. "Some days you don't even realize or notice that you're hearing everything. Then all of a sudden you'll have a CI (cochlear implant) moment. You'll hear a leaf hitting the ground and go,"Wow I heard that. It's amazing. I'm so fortunate."

#### Diana Bender HLAA National Convention Scholarship

The Hearing Loss Association of America Pennsylvania State Office (HLAA-PA) has established the Diana Bender HLAA National Convention Scholarship to assist Pennsylvania residents who are members of the Hearing Loss Association of America to attend the HLAA convention. (Note that membership in a chapter is not the same as membership in HLAA; the latter is required for scholarship eligibility.) One scholarship will be available for a deserving person who is currently involved with hearing loss issues. The HLAA-PA Advisory Council's Scholarship Committee will select the qualifying applicant.

When and where is the 2016 HLAA convention? The convention will be June 23-26 (four days, three nights) at the Washington Hilton 1919 Connecticut Avenue NW, Washington, DC.

Who is eligible as a scholarship candidate? Any Pennsylvania resident with hearing loss, regardless of age, is eligible as long as he or she meets the following qualifications. The applicant must be a current HLAA member, must have demonstrated an interest in remaining actively involved with hearing loss issues, and must indicate that a scholarship would enable his or her attendance. Preference will be given to those who have never attended an HLAA convention.

**Scholarship amount:** The recipient will be awarded \$500 (to be applied to transportation, lodging, and meals) plus the cost of registration for the full-activity convention package (includes banquet). Any amount exceeding \$500 will be his or her responsibility. The awardee must attend the convention or return the \$500.

**Submission date:** Application forms may be mailed or emailed (email preferred if possible). Deadline for receipt is <u>March 23, 2016</u>.
